

# Privacy Policy

We are committed to protecting your privacy, and support a general policy of openness about how we collect, use and disclose your personal information.

By using our Services or Website and/or our mobile/web application(s) (the "App"), you consent to the collection, use and disclosure of your personal information (as defined below) in accordance with the following terms and conditions.

This Privacy Policy also explains how you can contact us if you have a question about, want to make a change to or delete any personal information that WebEvolutions Sàrl may be holding about you. We strongly recommend that you take the time to read this Privacy Policy and retain it for future reference.

WebEvolutions Sàrl operates the Sunkhronos application in Europe, which offers B2B communication through the application named Sunkhronos and partner website(s) and mobile application(s) (collectively referred to as the "Sunkhronos application").

Any person utilizing the Sunkhronos application shall be bound by this Privacy Policy. WebEvolutions Sàrl respects the privacy of its Users and is committed to protect it in all respects. With a view to offer an enriching and holistic internet experience to its Users, WebEvolutions Sàrl offers a vast repository of Facilities.

The information about the User is collected by WebEvolutions Sàrl as (i) information supplied by Users and (ii) information automatically tracked during User's navigation on Sunkhronos. Before you submit any information to the Sunkhronos application, please read this Privacy Policy for an explanation of how we will treat your personal information.

By using any part of the Sunkhronos application, you consent to the collection, use, disclosure and transfer of your personal information for the purposes outlined in this Privacy Policy and to the collection, processing and maintenance of this information. If you do not agree to this Privacy Policy, please do not use the Sunkhronos application. Your use of any part of the Sunkhronos application indicates your acceptance of this Privacy Policy and of the collection, use and disclosure of your personal information in accordance with this Privacy Policy. While you have the option not to provide us with certain information or withdraw consent to

collect certain information, kindly note that in such an event you may not be able to take full advantage of the entire scope of features and services offered to you and we reserve the right not to provide you with our services.

**Purpose and Usage:** To avail certain features on the Sunkhronos application, Users would be required to provide certain information for the registration process namely: 1. Username 2. Password 3. Email address 4. Date of birth 5. State of residence In the course of providing you with access to the features, and in order to provide you access to the features and services offered through the Sunkhronos application and to verify your identity, you may be required to furnish additional information.

WebEvolutions Sàrl may also share such information with affiliates and third parties in limited circumstances, including for the purpose of providing services requested by the User, complying with legal process, preventing fraud or imminent harm, and ensuring the security of our network and services.

**Disclosure/Sharing:** WebEvolutions Sàrl reserves the right to disclose personal information as obligated by law, in response to duly authorized legal process, governmental requests and as necessary to protect the rights and interests of WebEvolutions Sàrl.

**Use of Cookies:** To improve the effectiveness and usability of the Sunkhronos application for our Users, we use "cookies", or such similar electronic tools to collect information to assign each visitor a unique random number as a User Identification (User ID) to understand the User's individual interests using the identified computer. Unless the User voluntarily identifies himself/herself (e.g., through registration), WebEvolutions Sàrl has no way of knowing who the User is, even if we assign a cookie to the User's computer. The only personal information a cookie can contain is information supplied by the User. A cookie cannot read data off the User's hard drive. Sunkhronos Sàrl's advertisers may also assign their own cookies to the User's browser (if the User clicks on their ad banners), a process that Sunkhronos Sàrl does not control. Sunkhronos Sàrl's web servers automatically collect limited information about User's computer's connection to the Internet, including User's IP address, when the User visits the Sunkhronos application. (User's IP address is a number that lets computers attached to the Internet know where to send data to the User -- such as the web pages viewed by the User). The User's IP address does not identify the User personally.

WebEvolutions Sàrl uses this information to deliver its web pages to Users upon request, to tailor its Sunkhronos application to the interests of its users, to measure traffic within the Sunkhronos application and let advertisers know the geographic locations from where Sunkhronos visitors come. However, we understand that as effective as our security measures are, no security system is impenetrable. Thus, we cannot guarantee the security of our database, nor can we guarantee that information you supply will not be intercepted while being transmitted to us over the Internet. Further, any information you include in a posting to the discussion areas if present will be available to anyone with Internet access. By using the Sunkhronos application, you understand and agree that your information may be used in or transferred to countries other than Switzerland. WebEvolutions Sàrl also believes that the internet is an ever-evolving medium. We may periodically review from time to time and change our privacy policy to incorporate such future changes as may be considered appropriate, without any notice to you. Our use of any information we gather will always be consistent with the policy under which the information was collected, regardless of what the new policy may be. Any changes to our privacy policy will be posted on this page, so you are always aware of what information we collect, how we use it, how we store it and under what circumstances we disclose it.
